As such, CGCSL is committed to providing a safe and healthy work environment for the prevention of injuries and illnesses. CGCSL'S senior management team consists of the President, the Health & Safety Manager and the Project Manager. The Senior Management Team takes full responsibility and accountability for the prevention of workplace injury and ill health as well as for the performance and success of the Health & Safety Management System. CGCSL's senior management team is committed to proactively improving occupational health and safety management system.

CGCSL is committed to develop its OHSMS in compliance with all applicable OHS legal requirements, along with all other requirements. CGCSL OHSMS encompass' the scope of our activities and outline the duties and responsibilities for all workplace parties.

CGCSL Senior Management team will maintain and review it OHSMS annually to evaluate previous OHS objectives and to set out new OHS objectives. CGCSL will implement changes as necessary based on the results of the annual review to ensure its OHSMS and performance continually improves.
